- 5. Sealed Bids must be submitted to the office on mentioned above. Bids received after this deadline shall not be entertained.
- 6. Bids must be valid for a period of 90 days after bid opening and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Khata No. 05703000000000000387 of Chautara Sangachokgadhi Municipality Office, Chautara, Sindhupalchok in the Office Code No. 23-365-14 of Nepal Bank Limited, chautara Branch and submit the receipt of the deposited amount of cash along with the Sealed Bid.
- 8. Bids shall be opened in the presence of Bidders' representatives who choose to attend at above mentioned date and time at the office of Chautara Sangachokgadhi Municipality.
- 9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
